Available Incentives

SWEPCO offers the following incentives to eligible Arkansas non-residential customers with more than 100 kW demand:

- ► Up to \$0.99 per kWh of energy savings for HVAC upgrades; up to \$0.14 per kWh of energy savings for lighting and other upgrades
- ▶ Up to 80 percent of project cost
- ▶ 100 percent of project cost for weatherstripping and door sweeps (electrically heated spaces) and faucet aerators (if electric water heating on site).

Eligible Projects

Incentives, savings, and payback periods depend on equipment installed, building characteristics, energy-use patterns, age of existing equipment, location, and other parameters. All projects require pre-inspection and post-inspection by a SWEPCO Energy Advisor. Custom projects will be considered on a case-by-case basis.

- ► LED lighting and lighting controls upgrades*
- HVAC upgrades and controls
- CoolSaver A/C Tune-Ups
- Motor and VFD retrofits
- Custom projects

- Air compressor replacements and leak repairs
- Food service equipment
- Refrigeration door gaskets, strip curtains, anti-sweat heater controls, evaporator fan controls, and more

Who Is Eligible?

Non-residential customers in Arkansas with a peak demand of more than 100 kW qualify for these incentives. Public-owned facilities such as schools and government buildings are eligible regardless of peak kW demand.

- Air compressor replacement (fixed speed to VFD)
- LED lighting retrofit (550 fluorescent lamps changed to LED lamps)
