- 3. Purchaser must be a SWEPCO residential customer in Arkansas. Appliances purchased must be installed at the location associated with the SWEPCO account number listed on this SWEPCO Incentive Form.
- 4. SWEPCO reserves the right to conduct random inspections to verify installation, which may take place prior to payment of incentive.
- 5. Only advanced power strip models listed on form are eligible for incentive.
- 6. The submitted SWEPCO Incentive Form must be postmarked within 90 days of purchase.
- 7. Customers must provide a copy of their sales receipt, which must indicate the retailer name, address, purchase date and price, proof of payment, product manufacturer, and model.
